TUITION

- **<u>Billing:</u>** Spring Session is billed in full (January-May)
 - We are working to have online payments up and running this summer. For now, you can pay in the studio with check or credit card.
- Payments: The first payment is due the first day of class and the second is due February 5th
- A LATE FEE OF \$5 IS ADDED TO ACCOUNTS EACH WEEK TUITION IS LATE.
- Tuition must be paid by Visa, Discover, MasterCard, check, or Money Order. WE DO NOT ACCEPT CASH.
- <u>No refunds will be given once classes have begun.</u> A student may make up missed classes in other appropriate like-classes. Make up classes can occur **ONLY** during the session they were missed. **Please be aware that once classes have begun working on recital pieces that even though the class may be the same genre they may have a different dance they are working on.

Please make sure that you have read our Student & Parent Handbook & have signed the Participant Waiver & Release Form. Dancers who do not have the waiver filled out will not be able to participate in class until it is completed.

PORTAL ACCOUNTS: Online accounts are still being adjusted, so if you log in to your account and don't understand your current balance, don't worry! We are working diligently to adjust them as payments are being made!

LOST & FOUND: Items in the Lost & Found will be donated on the last Friday of each month. Please make sure you have all your belongings.

RECITAL THEME: Instructors are already picking out music for this year's spring recital. We look forward to our Spring Recital Theme: "Celebrating 40 years of Dance" Our dress rehearsals and spring recitals will be held at NDSU Festival Hall May 19th & 20th.

RECITAL COSTUMES: We will be measuring for costumes the first few weeks of classes already! Please remember costume fees are non-refundable. Prices will range between \$35-\$60 per costume. We realize that costumes get to be expensive and we will do our best to keep our costs down, especially for those in multiple classes.

- **<u>Billing:</u>** Costumes will be billed in the middle of February
- <u>Payment:</u> Costume fees are DUE March 1st.
- Whether or not the class is dropped or the student decides not to participate in recitals, they are still responsible for costume payments.

SPRING RECITAL: All our dancers participate in the Spring Recital "Celebrating 40 years of Dance." Mark your calendars for Saturday, May 19th and Sunday, May 20th! More information will be sent home as soon as we have the rehearsal and performance schedules. (*Anticipate beginning of April*)

PICTURE WEEK: Every year we have Scherling Photography come to Red River Dance to take pictures of each class wearing their recital costumes! Scherling photography will be at the studio the week of May 7-12 for Picture Week. We will take pictures for each class as close to their scheduled class times as possible. Dancers will be required to wear their costumes, tights, and shoes. If dancers are supposed to do their hair in any special way with hair pieces they will be sent home with special instructions. More information will be sent home as soon as we have the picture day schedule and hair, and costume information. (Anticipate beginning of April)

FATHER/DAUGHTER PROGRAM: This program is **FREE** to your dancers and fathers! (Brothers, Uncles, Step-Fathers, & Grandfathers are welcome too!) We are proud to say that this is our fourth year offering this program. It is a great opportunity to create memories to last a lifetime. When will my gift cards arrive?

Red River Dance orders the Scrip gift cards bi-weekly! We process orders after every other Tuesday and your gift cards will be ready to take home by the following Monday or Tuesday. For example: If you drop off your order invoice/form with corresponding check on Wednesday, we will process the order at the end of Tuesday and your gift cards will arrive by the following Tuesday! DRESS CODE

Creative Movement: Athletic wear, pink ballet slippers, socks, or bare feet!

Ballet/Tap 3-4 years old: Any colored leotard, pink tights, pink ballet slippers, optional skirt, black tap shoes, & hair in bun or pulled back and pinned somehow if not long enough.

Ballet/Tap 5-6 years old: Any colored leotard, pink tights, pink ballet slippers, optional skirt, black tap shoes, & hair in bun or pulled back and pinned somehow if not long enough.

Hip Hop 5-6 years old: Athletic Wear! Baggier clothes are acceptable as long as they are not a distraction or that they drag on the floor. Dancers can wear tennis shoes or combat boots (not worn outside).

Ballet/Jazz 1: Any colored leotard, pink tights, pink ballet slippers, optional skirt, tan jazz shoes, spandex shorts & hair in bun.

Ballet/Jazz 2: Black leotard, pink tights, pink ballet slippers, optional skirt, tan jazz shoes, spandex shorts (to change into for jazz), & hair in bun. Ballet 1, 2, 3, 4, & 5: Black leotard, pink tights, pink ballet slippers, optional skirt (any color), & hair must be in a bun. (If hair is not long enough, please make sure it is pulled back and pinned securely out of the face).

Jazz 1, 2, 3, 4, & 5: Fitted athletic clothing or leotards. Example: black spandex shorts, and a form-fitting tank top. Tan jazz shoes are required. Hair must be secured back to minimize distraction.

Tap 1,2,3,4, & 5: Fitted athletic clothing or leotards. Please wear capris or shorts and have black tap shoes.

Lyrical 2, 3, 4, & 5: Ballet or Jazz clothing acceptable. Hair must be secured back. Shoes: Tan Twyla half shoe

Hip Hop 7-10, 11-14, & 15+: Athletic Wear. Baggier clothes are acceptable as long as they are not a distraction or drag on the floor. Dancers can wear tennis shoes or combat boots (not worn outside).

Tappercise: Fitted athletic wear, & black tap shoes. Fitness Classes: Athletic clothing, tennis shoes.

WHERE TO FIND SHOES + DANCEWEAR:

You can find limited dancewear and shoes in stores like Payless, Target, or Walmart. Applause Costumes and Dancewear in Moorhead has the largest selection. CLASS ATTENDANCE: Maintaining regular attendance is VITAL to student progress and group choreography. Attendance is necessary if a student wants to show a marked degree of improvement and allow teachers to do the best job possible. Absences and tardiness's can severely hold back a class. As a class, we count on everyone to be there! Let us know if about any dates a student will be absent. Please call us at 701.280.0004 before 4:00pm so we can make sure that instructors are aware prior to the start of class.

REHEARSAL ATTENDANCE: Like classroom attendance, it is crucial to have 100% attendance for rehearsals. Schedules for rehearsals will be posted in advance and it is expected that dancers attend ALL rehearsal scheduled.

STUDIO, LOBBY, AND STAGE CONDUCT: Everyone must clean up after themselves, whether it is in the studios, or in the lobby. Individuals who leave messes including food, scattered personal belongings, props, and other various items in any area will be required to leave class or rehearsal to take care of their mess. If the person responsible is not found, at the end of class all dancers will be required to stay long enough to ensure cleanup. Use of foul or obscene language/gestures and gossip will not be permitted, regardless of age. Please remember that Red River Dance & Performing Company facilitates students of all ages. Out of respect for ourselves and others, please act with prudence.

DISMISSAL FROM CLASS OR REHEARSAL: Dancers will be dismissed from class for too much talking, lack of effort, not being prepared, or for inappropriate language & behavior such as bullying. Parents will be made aware of the problem and if it

becomes a regular issue, an oral review will be scheduled. If dress code is not followed dancers will get a warning and if it becomes a recurring, they may be asked to leave class.

PARENT CODE OF CONDUCT

I recognize the importance of performing arts in the lives of young people; I pledge that I will participate in my child's dance activities in accordance with the following:

- I will promote teamwork and sportsmanship for all students, instructors, board members, and spectators in a positive manner.
- I will not question the judgement of any faculty member or choreographer in public. I will take the time to speak with instructors and directors at agreed upon time and place.
- I will support my child's class, teachers, and choreographers and resolve to allow the teachers to manage their dancers and choreography as they feel best benefits the entire class.
- I will exhibit exemplary behavior at the studio and at performances. I realize that I am a role model for my child as well as the other dancers and my personal conduct at the studio, performances and other studio events must represent the highest standards of morality, teamwork, and sportsmanship. I will refrain from gossip, profane language, and negativity.
- I will at all times control my emotions and will be considerate of all dancers and parents' collective emotions, remembering children participate to have fun.
- I will not make disparaging remarks of any type with regard to teachers, dancers, choreographers, choreography placement, costumes, other parents, other schools, or publicly criticize them in the studio or during any event. 3 \Box I will direct all inquiries to The Red River Dance & Performing Company Directors.
- I will encourage my child in a positive manner at all times
- I will not make a judgement on my child's performance and always be there to support them.
- I will never make a negative comment concerning other parents or their children, whether they are from Red River Dance & Performing Company or another studio.
- I will always applaud for all dancers, remembering the art of dance allows all to shine.
- I will refrain from coaching my child or other dancers during practice, performances, or competitions.
- I will demand a healthy environment for my child that is free from drugs, tobacco, and alcohol.
- I will use social media such as Facebook, Instagram, Twitter, etc. in a respectful manner and expect the same from my child.

STUDENT CODE OF CONDUCT

I pledge that I will participate in dance at Red River Dance & Performing Company in accordance with the following:

- We will work as a team, building positive images of company and ourselves whether in rehearsal, performance, or competition.
- We will be a high-energy school. Dancers are expected to demonstrate a high level of enthusiasm and commitment dedicating essential attributes in order to fully develop our artistic talents, physical skills, and mental capabilities.
- Performing Company members are expected to meet a higher standard in their work ethic. Supporting not only the Performing Company, but also the Red River Dance & Performing Company and its many needs (For example, assisting the Directors, Instructors, Company Members, and other dancers at the studio).
- I will not question the judgement of any faculty member or choreographer.
- I will exhibit exemplary behavior at the studio and at performances.
- I will at all times control my emotions and will be considerate of others.
- I will not make negative remarks of any type with regard to teachers, choreographers, choreography placement, costumes, other parents, other schools, or publicly criticize them in the studio or course of any event.
- I will not engage in bullying. 🗆 I will direct all inquiries to The Red River Dance & Performing Company Directors.
- I will not make a judgement on my other dancer's performances and choose to support them and all other dancers.
- I will never make a negative comment concerning other parents or their children, whether they are from Red River Dance & Performing Company or another school.
- I will always applaud for all dancers.
- I will use social media such as Facebook, Instagram, Twitter, etc. in a respectful manner.
- I will refrain from using drugs, tobacco, and alcohol.
